## Board's Decision in Respect of Procedural or Jurisdictional Matters:

N/A

<u>Property Description:</u> Property is located in the Manchester industrial area and contains two office/ warehouse buildings on an irregular shaped parcel. The parcel contains 1.83 acres while the buildings, constructed in 1970, have 33,500 and 4,000 sq ft. Site coverage for the site is 43.15 %. The assessment rate per square foot is \$115.00. In the City of Calgary Land Use By law, the property is designated Industrial General (I-G) district.

<u>Issues:</u> The Complainant raised the following matters in Section 4 of the Assessment Complaint form: Assessment amount and Assessment class.

A large number of issues were outlined in Section 5 of the complaint form. Presentations of the Complainant and Respondent were limited to the following issues raised by the Complainant:

- Assessment overstated in relation to comparable properties.
- Sales approach indicates assessment is overstated.

Complainant's Requested Value: \$3,900,000.00

## Board's Decision in Respect of Each Matter or Issue:

<u>Complainant's position</u>: The Board was presented with a large number of equity comparables from 2010. These properties have a median sq ft assessment of \$104.00. These properties were located in NE and SE Calgary. The sale comparison (2006-2009) data indicated a rate of \$105.00 per square foot. Additional industrial assessment data had been submitted however not referenced in the presentation.

Respondent's position: : In its brief, the City provided seven 2010 equity comparables for each building as well as 7 industrial sales comparables. The sales comparables dated from 2007-2008 and were all located in the North East. The City acknowledged that the Complainant's position had some merit.

Board considers that the Complainant's position had merit and reduced the assessment to \$4,010,000.00.

<u>Reasons</u>: The Board found that both parties brought forward for consideration good information, however, determined that the Complainant's information to be more compelling. The Board utilized a rate of \$107.00 per sq ft to determine the assessment.

- (c) the municipality, if the decision being appealed relates to property that is within the boundaries of that municipality;
- (d) the assessor for a municipality referred to in clause (c).

An application for leave to appeal must be filed with the Court of Queen's Bench within 30 days after the persons notified of the hearing receive the decision, and notice of the application for leave to appeal must be given to

- (a) the assessment review board, and
- (b) any other persons as the judge directs.
