No specific jurisdictional or procedural issues were raised, and the CARB proceeded to hear the meritsof the complaint.

### **Property Description and Background:**

The subject is a retail strip centre, located in the Abbeydale district of NE Calgary. The building is 11,570s.f. . The land area is 0.99 acres. The property is assessed using the income approach, which produces an assessment of \$201.38 per s.f.

#### Issues:

A number of issues, all relating to the income capitalization calculations were raised on the complaint form. However, upon reviewing the evidence, the Complainant chose to withdraw the complaint, and did not wish to proceed further.

#### Complainant's Requested Value:

\$2,180,000.00 on the Complaint form, but withdrawn at the hearing.

### **Board's Decision**

The assessment is confirmed at \$2,330,000 with the consent of both parties.
