Board's Decision in Respect of Procedural or Jurisdictional Matters:

[1] The Board derives its authority to make this decision under Part 11 of the Municipal Government Act (the "Act"). The parties had no objections to the panel representing the Board as constituted to hear the matter.

Preliminary Matter:

- [2] At the outset of the hearing the Complainant requested the Board to confirm the assessment as currently stated at \$3,350,000.00.
- [3] When questioned, the Respondent had no objection to the confirmation of the assessment.

Property Description:

[4] The subject property contains a multi-bay warehouse (IN0701) constructed in 1970. The structure, rated as 'C' quality, is located at 6045 Centre Street SW in the Manchesterl Industrial Area. The structure, situated on a 1.44 acre parcel, has an assessable area of 25,200 square feet, assessed at a rate of \$133.08 per square foot, using the Sales Comparison Approach. The property has a site coverage of 40.11% and an interior finish of 39%.

Complainant's Requested Value: \$3,350,000.00

Board's Decision:

- [5] The Board, accepted the request of the Complainant to confirm the assessment as currently set by the City of Calgary.
- [6] The Decision of the Board was to confirm the assessment at \$3,350,000.00

- (d) the assessor for a municipality referred to in clause (c).

An application for leave to appeal must be filed with the Court of Queen's Bench within 30 days after the persons notified of the hearing receive the decision, and notice of the application for leave to appeal must be given to

- (a) the assessment review board, and
- (b) any other persons as the judge directs.
