ISSUE

Should a postponement of the 2011 complaint hearings scheduled for July 11, 2011, be granted as requested by the Complainant?

POSITION OF THE COMPLAINANT

The Complainant requests a postponement of the complaint hearings scheduled for July 11, 2011 on the basis that two witnesses are involved in other hearings in Newfoundland and are unable to attend the ARB hearing. The Complainant further requests that disclosure dates are amended to reflect the new hearing dates.

POSITION OF THE RESPONDENT

The Respondent takes no position in regard to the postponement request.

LEGISLATION

S.15 (1) of the *Matters Relating to Assessment Complaints Regulation*, Alberta Regulation 310/2009 (MRAC), states:

- (1) Except in exceptional circumstances as determined by an assessment review board, an assessment review board may not grant a postponement or adjournment of a hearing.
- (2) A request for a postponement or an adjournment must be in writing and contain reasons for the postponement or adjournment, as the case may be.
- (3) Subject to the timelines specified in section 468 of the Act, if an assessment review board grants a postponement of adjournment of a hearing, the assessment review board must schedule the date, time and location for the hearing at the time the postponement or adjournment is granted.

DECISION

The Board grants the postponement request.

REASONS FOR THE DECISION

The Board is satisfied that a postponement of the hearings is warranted to ensure that the Complainant's witnesses attend the hearing. The Board notes that the Respondent takes no position in regard to the postponement.

As per s.15(3) of MRAC, the Board has rescheduled the hearings as follows:
