1. At the commencement of the hearing, the parties were sworn in.

2. Upon questioning by the Presiding Officer, the parties present indicated no objection to the composition of the Board. In addition, the Board members indicated no bias with

respect to this file.

**PRELIMINARY MATTERS** 

At the beginning of the hearing the Respondent advised that he recommended that the 2010 assessment be reduced from \$2,338,000 to \$2,142,000. The Complainant agreed with this recommendation. Both parties signed the form headed "Withdrawal and Agreement to

Correction of Assessment".

**LEGISLATION** 

The Board has regard for ss. 467(1) and 467(3) of the *Municipal Government Act*, R.S.A. 2000, c. M-26 (MGA) prohibiting the alteration of an assessment that is fair and equitable and also s.2

of *Matters Relating to Assessment and Taxation Regulation* (M.R.A.T) regarding the requirement to assess property using mass appraisal.

**DECISION** 

The Board decided that, pursuant to the agreement between the Parties, the 2010 assessment be

reduced to \$2,142,000.
