PRELIMINARY MATTERS

Upon commencement of the hearing, the Complainant informed the Board that the Respondent made a recommendation to reduce the subject property's assessment to \$4,152,200 as a result of a size correction. The size of the subject property was reduced from 15,430 square feet to 15,000 square feet inclusive of 994 square feet of storage space. The Complainant advised the Board that the recommendation has been accepted.

ISSUE(S)

Is the current assessment of the subject property fair and equitable?

LEGISLATION

Municipal Government Act, RSA 2000, c M-26

s 467(1) An assessment review board may, with respect to any matter referred to in section 460(5), make a change to an assessment roll or tax roll or decide that no change is required.

s 467(3) An assessment review board must not alter any assessment that is fair and equitable, taking into consideration

- a) the valuation and other standards set out in the regulations,
- b) the procedures set out in the regulations, and
- c) the assessments of similar property or businesses in the same municipality.

DECISION

The 2011 assessment is reduced to \$4,152,000.

REASONS FOR THE DECISION

The Board reduced the assessment of the subject property based on the recommendation of the Respondent as accepted by the Complainant.
