### ISSUE(S)

The correct assessment of the subject property.

## **LEGISLATION**

#### Municipal Government Act, RSA 2000, c M-26

s 467(1) An assessment review board may, with respect to any matter referred to in section 460(5), make a change to an assessment roll or tax roll or decide that no change is required.

s 467(3) An assessment review board must not alter any assessment that is fair and equitable, taking into consideration

- a) the valuation and other standards set out in the regulations,
- b) the procedures set out in the regulations, and
- c) the assessments of similar property or businesses in the same municipality.

#### POSITION OF THE COMPLAINANT AND RESPONDENT

The parties, at the opening of the hearing, jointly submitted a recommendation signed by representatives for both parties, stating that the subject property should be assessed at a value of \$13,203,000 on the basis of a correction to a data error.

### **DECISION**

The 2011 assessment for the subject property is revised to \$13,203,000.

### **REASONS FOR THE DECISION**

The Board is aware that as a result of this hearing being held in 2012 with regard to a 2011 assessment, the Respondent has been asking the Board to issue decisions in circumstances which would otherwise be dealt with by a withdrawal to correction. The Board decision is to give effect to the agreement of the parties, and revise the assessment as requested by both parties.
