A hearing was held on December 6 and 7, 2010, in Fort McMurray in the Province of Alberta to consider further preliminary issues related to complaints about the assessment of the following property tax roll number:

8992004910 Assessment \$249,499,140.00 RMWB file 10-001

PART A: BACKGROUND AND DESCRIPTION OF PROPERTY UNDER COMPLAINT

The roll number relates to a property assessment for building and structures, namely three camps at the Canadian Natural Resources site. The Complainant questions whether the assessment takes into account the shut-in state of two of these camps and the under-utilized nature of the third.

In addition, the Complainant questions the assignment of a non-residential property classification to this property.

PART B: PROCEDURAL MATTERS

During the September 2010 preliminary hearing, the parties advised CARB that they had reached a tentative settlement of the issues. CARB was advised that the parties would be sending written confirmation to CARB regarding the settlement.

By November 30, 2010 CARB had not received the confirmation of settlement. During the preliminary hearing held December 6 and 7, 2010, CARB requested an update of the status of the settlement. The parties reported to CARB in late December. As a result of the advice of the parties that a settlement had not been reached, the CARB scheduled a hearing of the merits of this matter for March 14 - 16, 2011 in Fort McMurray.

On March 1, 2011, the parties sent to the Board a joint recommendation to change the assessment of the above roll number from \$249,499,140.00 to \$243,012,920.00 as a result of the following reduction:

REASONS – ISSUE 1

The CARB notes that although this issue had been dispute between the parties, by virtue of discussions held from September 2010 through March 2011, the parties were able to reach a resolution regarding a change to the assessment roll. On the understanding that this reflects the fair market value of the building and structures, the CARB is prepared to accept the joint recommendation of the parties and thanks the parties for their work in reaching a resolution of this matter.

DECISION - Roll # 8992004910 (work camps)

The CARB directs that Roll # 8992004910 (work camps) be reduced from \$249,499,140 to \$243,012,290.
