POSTPONEMENT DECISION OF Harold Williams, Presiding Officer Mary Sheldon, Board Member Martha Miller, Board Member

#### Issue

[1] Should a postponement of the 2013 Annual New Realty Assessment hearing scheduled for June 25, 2013 be granted as requested by the Respondent?

#### Legislation

- [2] The Matters Relating to Assessment Complaints Regulation, AR 310/2009, reads:
  - 15(1) Except in exceptional circumstances as determined by an assessment review board, an assessment review board may not grant a postponement or adjournment of a hearing.
  - (2) A request for a postponement or an adjournment must be in writing and contain reasons for the postponement or adjournment, as the case may be.
  - (3) Subject to the timelines specified in section 468 of the Act, if an assessment review board grants a postponement of adjournment of a hearing, the assessment review board must schedule the date, time and location for the hearing at the time the postponement or adjournment is granted.

## **Position Of The Respondent**

[3] At the commencement of the hearing of the merits of this appeal, the Respondent provided a written request that this matter be postponed to September 19, 2013. The Respondent submitted that this would allow the matter to be heard consecutively with roll number 9971414

which shares an appraisal. The Respondent was of the view that postponing the matter would provide a more efficient means of hearing this appeal and other similar appeals.

# **Position Of The Complainant**

[4] The Complainant agreed with the Respondent's request and echoed the submission that postponing the matter would be more efficient for all involved.

### **Decision**

- [5] The Board grants the postponement request.

- [7] No new notice of the postponed hearing will be sent.
- [8] The Board directs that no further evidence be submitted in regard to this matter.

- [10] The Board notes that the parties are in agreement in relation to this postponement request.
