

Assessment & Amended Notice Complaint Date Schedule for 2018

Amendments to the *Municipal Government Act* (MGA) that came into force January 1 include changes to the timeline for sending of assessment notices, changes to the definition of Notice of Assessment date, and changes to the definition of complaint deadline. Below is the schedule of mailing date, notice of assessment date and the final complaint deadline.

Sending assessment notices

*310(1) Subject to subsections (1.1) and (3), assessment notices must be sent no later than **July 1** of each year*

310(3) An assessment notice must be sent at least 7 days prior to the notice of assessment date.

The *Interpretation Act* section 22(3) provides that where an enactment refers to clear days or to “at least” or “not less than” a certain number of days between two events (such as section 310(3) of the MGA) in calculating the number of days, the days on which both the events occur are to be excluded. For example, if the Notice is sent on January 2, the Notice of Assessment is Jan 10. This is due to requirement for 7 clear days (Jan 3, 4, 5, 6, 7, 8, and 9) between Notice Sent Date and Notice of Assessment Date.

Notice of assessment date

308.1(1) An assessor must annually set a notice of assessment date, which must be no earlier than January 1 and no later than July 1.

(2) An assessor must set additional notice of assessment dates for amended and supplementary assessment notices, but none of those notice of assessment dates may be later than the date that tax notices are required to be sent under Part 10.

Complaint deadline

284(4) In this Part and Parts 11 and 12, “complaint deadline” means 60 days after the notice of assessment date set under section 308.1 or 324(2)(a.1).
